1. About Kernel for PST Compress and Compact

1.1 Using this Manual

This user manual is intended to guide users on using Kernel for PST Compress and Compact. 1.2 Introduction to Kernel for Compress and Compact

Kernel for PST Compress and Compact is comprehensive, result oriented PST compression software intended to remove extra unused space from PST file(s) and compacting PST. Using this wonderful utility, one can compress multiple PST files in one cycle. The software has been designed in such a way that it not only compresses the selected PST file(s) but also facilitates you to remove attachments from the PST file(s). Kernel for PST Compress and Compact provides following options to let you quickly and effectively decrease the size of PST file(s):

- **Compress all attachments in new PST file:** Compresses the selected PST file(s) including attachments and saves the compressed PST file(s) at a new location.
- **Remove all attachments in new PST file:** Removes all attachments from the selected PST file(s) and saves them in new PST file at the specified location.
- **Remove all attachments from new PST file and save them in separate folder:** Removes all attachments from the new PST file and saves them in another folder at user-defined location.
- **Remove all attachments from new PST file. Compress and save them in separate folder:** Removes all attachments from PST file, compresses the attachments, and saves them in a new folder at the user-defined location.

1.3 Key Features

Distinguished features of Kernel for PST Compress and Compact software are:

- Compresses multiple PST files in one go. Maximum of 2147483648 PST files can be compressed in single cycle
- Creates and saves the compressed PST file at a user-defined location
- Creates a separate folder for every compressed PST file
- Helps you decrease the size of PST file by removing extra space from the PST and / or by removing attachments from the PST
- Enables you to protect the PST file from reaching its size limit; therefore, saves the PST file from being damaged
- Self-descriptive user interface
- Supports MS Outlook 2002, Outlook 2003, and Outlook 2007
- Provides round the clock technical support
- Available for free demo

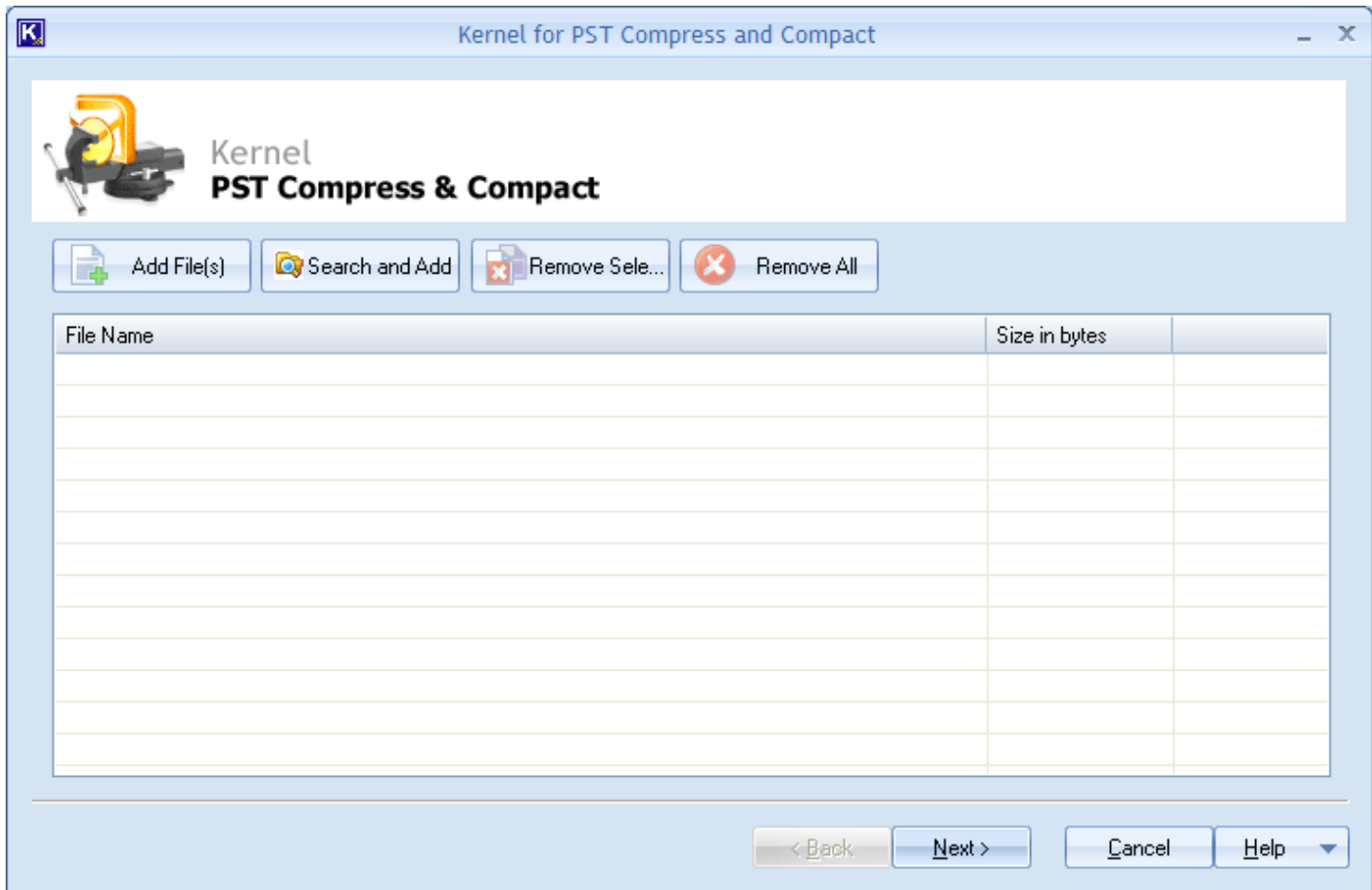

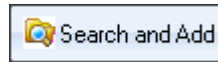


Figure 2.1 : Main Window

Following are the main buttons used for compressing and compacting MS Outlook PST file:

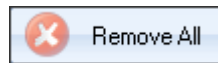
Button	Button Description
	Allows you to select PST file(s) that you want to compress



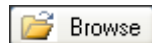
Allows you to search PST file(s) on your computer system to compress



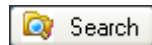
Removes the selected PST file from the list of PST files that you have added for compression



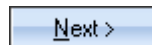
Removes all listed PST files



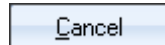
Opens the "Browse for Folder" dialog box to help you select the location where the software searches PST file(s)



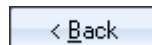
Searches the PST file(s) at the browsed location



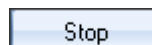
Takes you a step ahead in the ongoing process



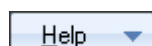
Closes the software

3. Install and Uninstall

3.1 Install the Software

Now, when you are well acquainted with the software features and its benefits, let us install the software to take its advantage. However, before installing the software, you must confirm that the software installer file is available on your computer system or at any other storage media from where you want to install the software. If the file is not available then obtain the installer file of Kernel for PST Compress and Compact from - <http://www.nucleustechnologies.com/download-compress-pst.html>


After you have made sure that, the installer file is available, follow the below given steps to install the Kernel for PST Compress and Compact software:

1. Double-click the Kernel for PST Compress and Compact installer file.
2. Follow the on-screen instructions. After the installation process is completed, the “**Setup Installation Complete**” message will be displayed.
3. Click the **Finish** button to launch the software.

3.2 Uninstall the Software

To uninstall Kernel for PST Compress and Compact from your system, you can use any of the two methods described below:

1. Uninstall from Windows Start menu
2. Uninstall from Control Panel

 While un-installing, make sure that no component of Kernel for PST Compress and Compact software is running in the system background.

Uninstall from Windows Start Menu

To uninstall Kernel for PST Compress and Compact from Windows Start menu, follow these steps:

1. Click the **Start** button from the Windows menu.
2. Click **All Programs > Kernel for PST Compress and Compact > Uninstall Kernel for PST Compress and Compact**.
3. A warning message before un-installing will be displayed on the screen. Click '**Yes**' to uninstall the software.

Kernel for PST Compress and Compact is now successfully uninstalled from your computer system.

Uninstall from Control Panel

To uninstall Kernel for PST Compress and Compact from Control Panel, follow these steps:

1. Click the **Start Menu > Control Panel** and then double click the Add or Remove Programs icon.
2. Select **Kernel for PST Compress and Compact** and click **Remove**.
3. A warning message before un-installing the software will be displayed on the screen. Click '**Yes**' to un-install the software.

Kernel for PST Compress and Compact is now successfully uninstalled from your computer system.

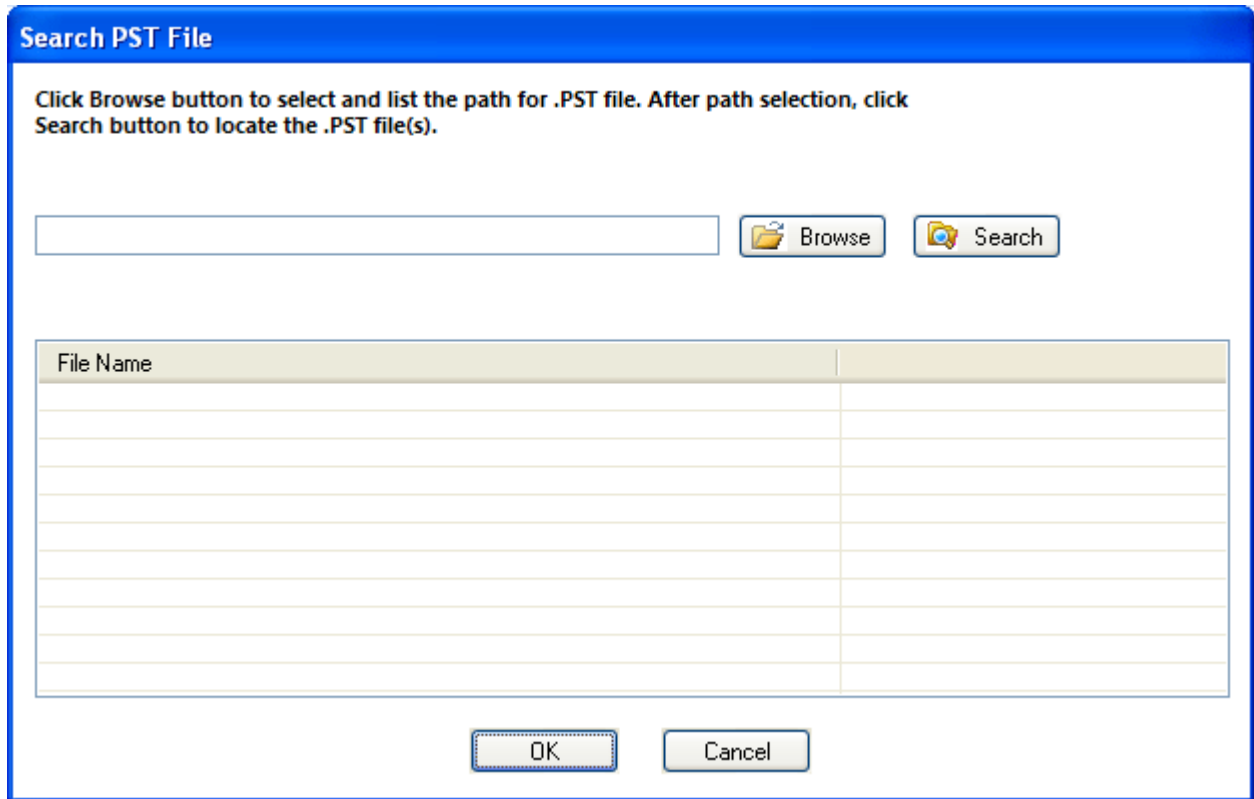


Figure 4.2: Search PST File

4. Click the Browse button. The “Browse for Folder” dialog box appears:

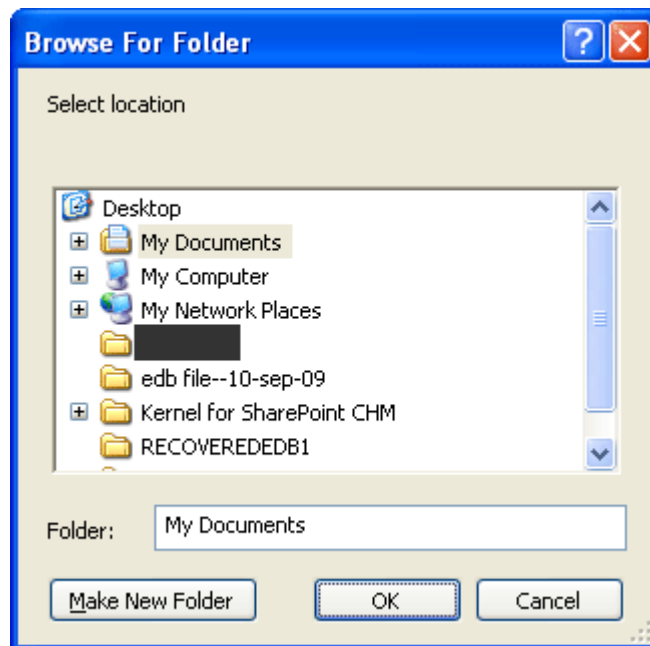


Figure 4.3: Browse For Folder

5. Select the folder or the hard disk drive where you want the software to search PST file(s) and click the **OK** button.
6. After selecting the location, click the **Search** button. The software starts searching PST file(s). When the search process completes, the software lists the files along with their location:

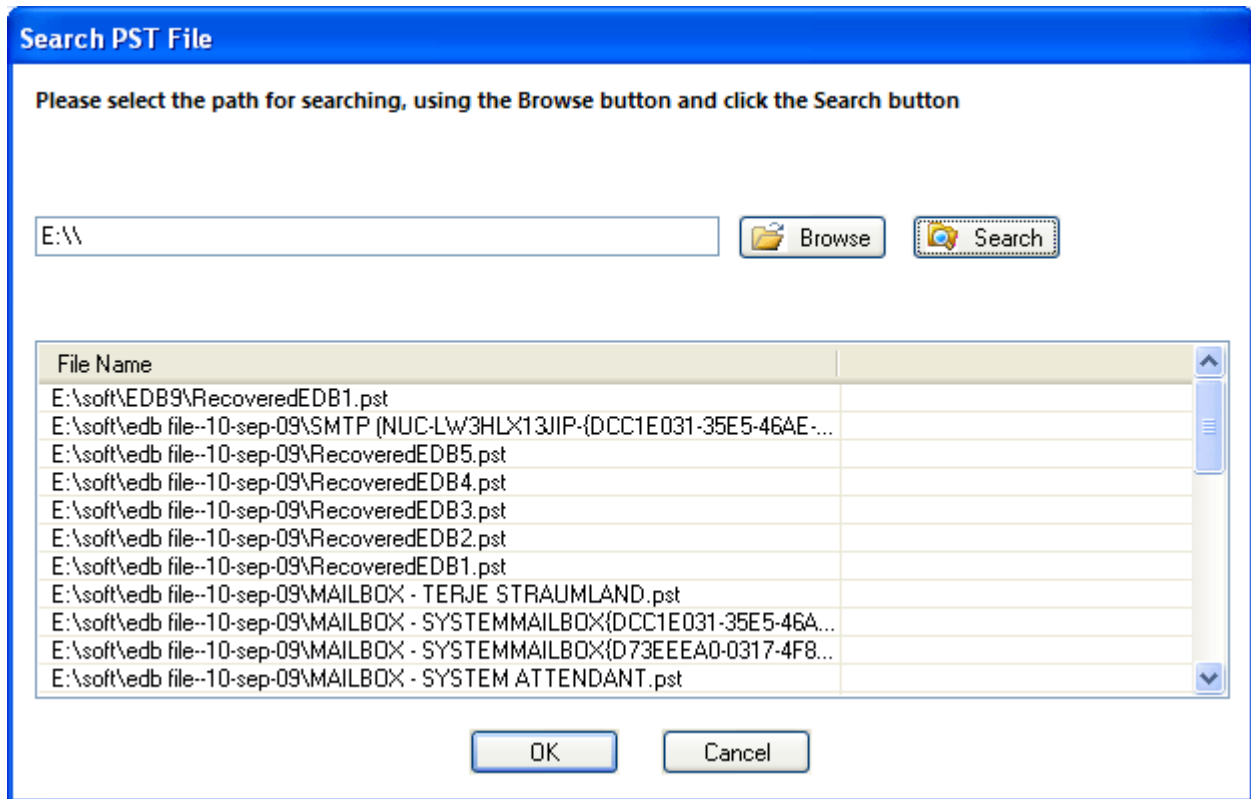


Figure 4.4 : Select PST File

7. Select the file(s) that you want to compress. Press and hold **CTRL** key to select multiple PST files.
8. Click the **OK** button. All of the selected files are listed in the main window along with their location and size:

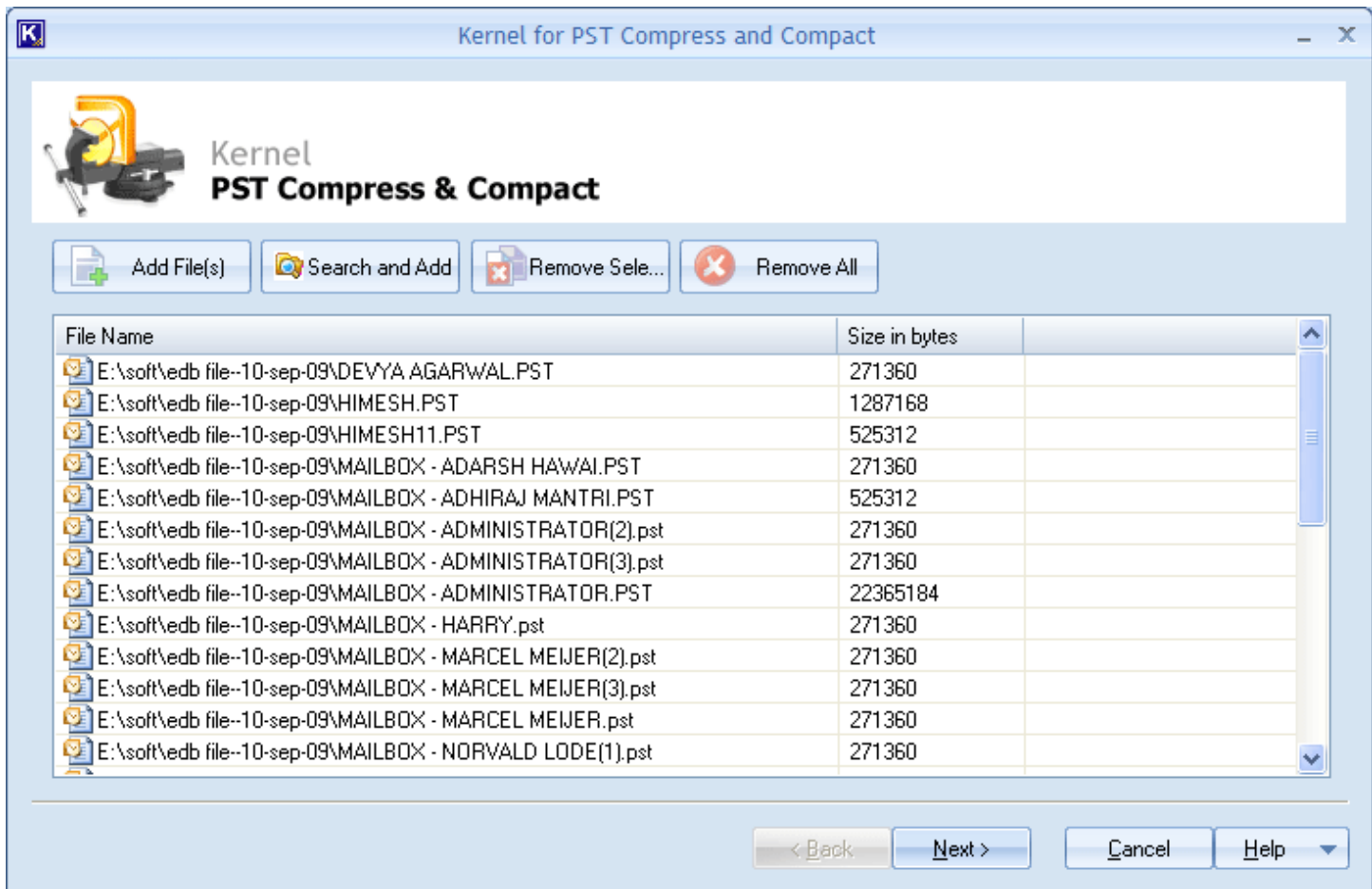


Figure 4.5: Selected PSTs

9. Click the **Next** button. The “Compress Options” page appears:

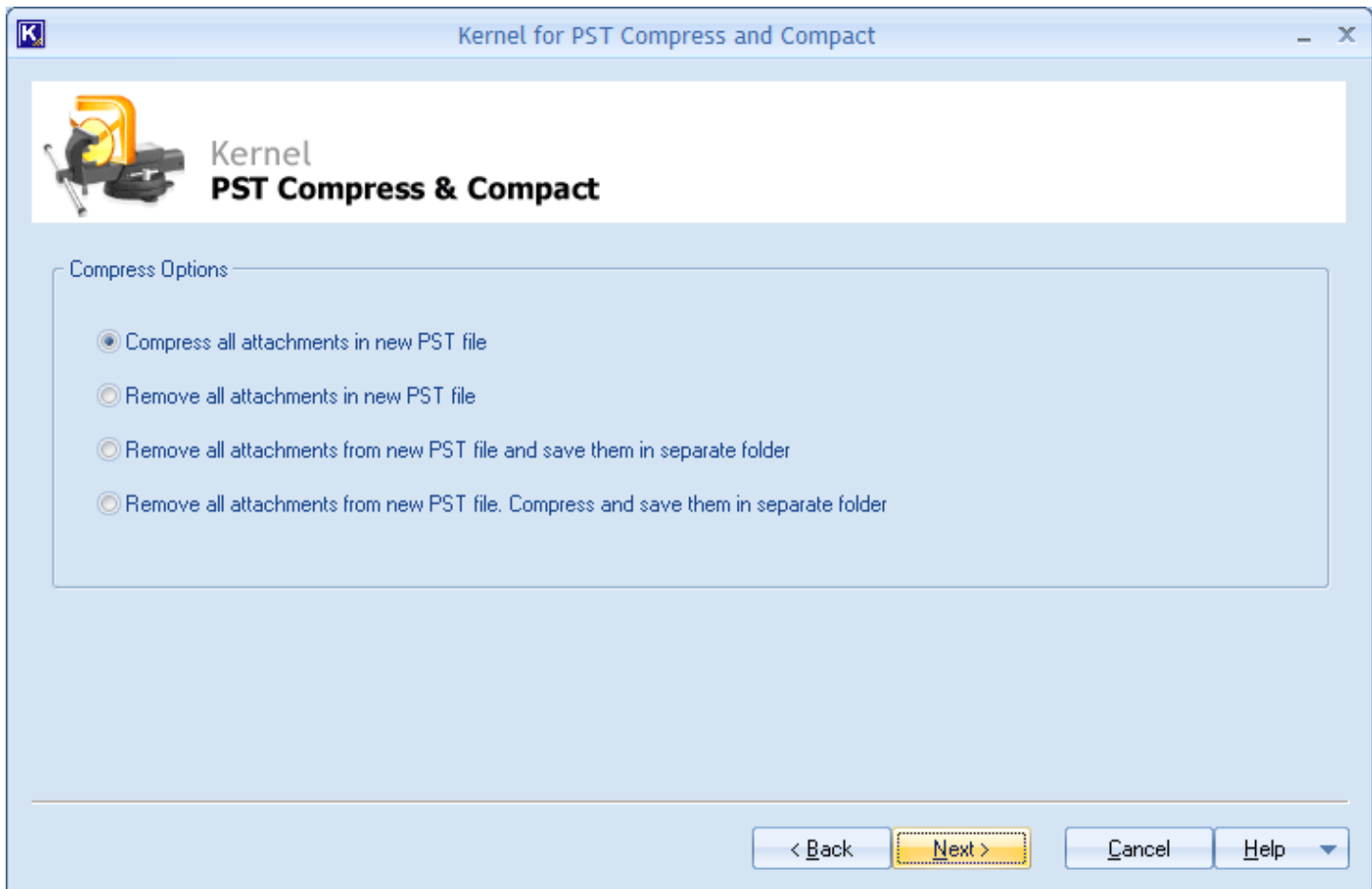


Figure 4.6: Compress Options

Kernel for PST Compress and Compact provides following options to let you compress the selected PST file(s):

- **Compress all attachments in new PST file:** Compresses the selected PST file(s) including attachments and saves the compressed PST file(s) at a new location.
- **Remove all attachments in new PST file:** Removes all attachments from the selected PST file(s) and saves them in new PST file at the specified location.
- **Remove all attachments from new PST file and save them in separate folder:** Removes all attachments from the new PST file and saves them in another folder at user-defined location.
- **Remove all attachments from new PST file. Compress and save them in separate folder:** Removes all attachments from PST file, compresses the attachments, and saves them in a new folder at the user-defined location.

10. Select the required option and click the **Next** button. The “Please provide destination and temporary path” dialog box appears:

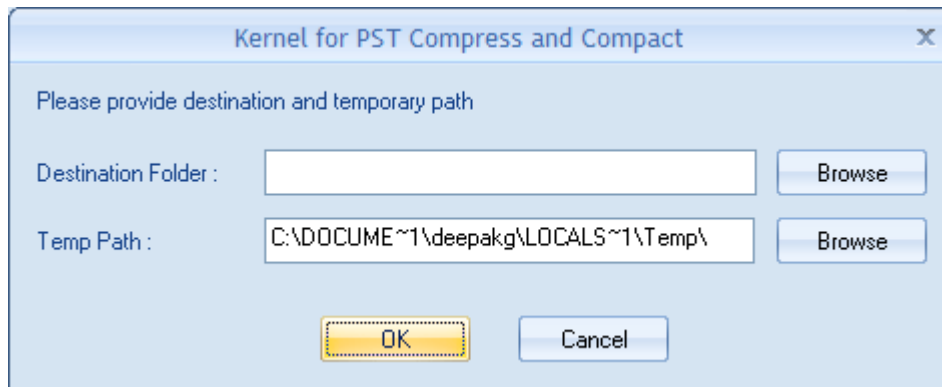


Figure 4.7: Saving location

11. Click the **Browse** button beside the **Destination Folder** text box to specify the location where you want to save the compressed PST file(s).
12. Click the **Browse** button beside the **Temp Path** text box to specify the location where the software saves the temporary files.
13. Click the **OK** button. The software starts compressing the selected PST file(s).

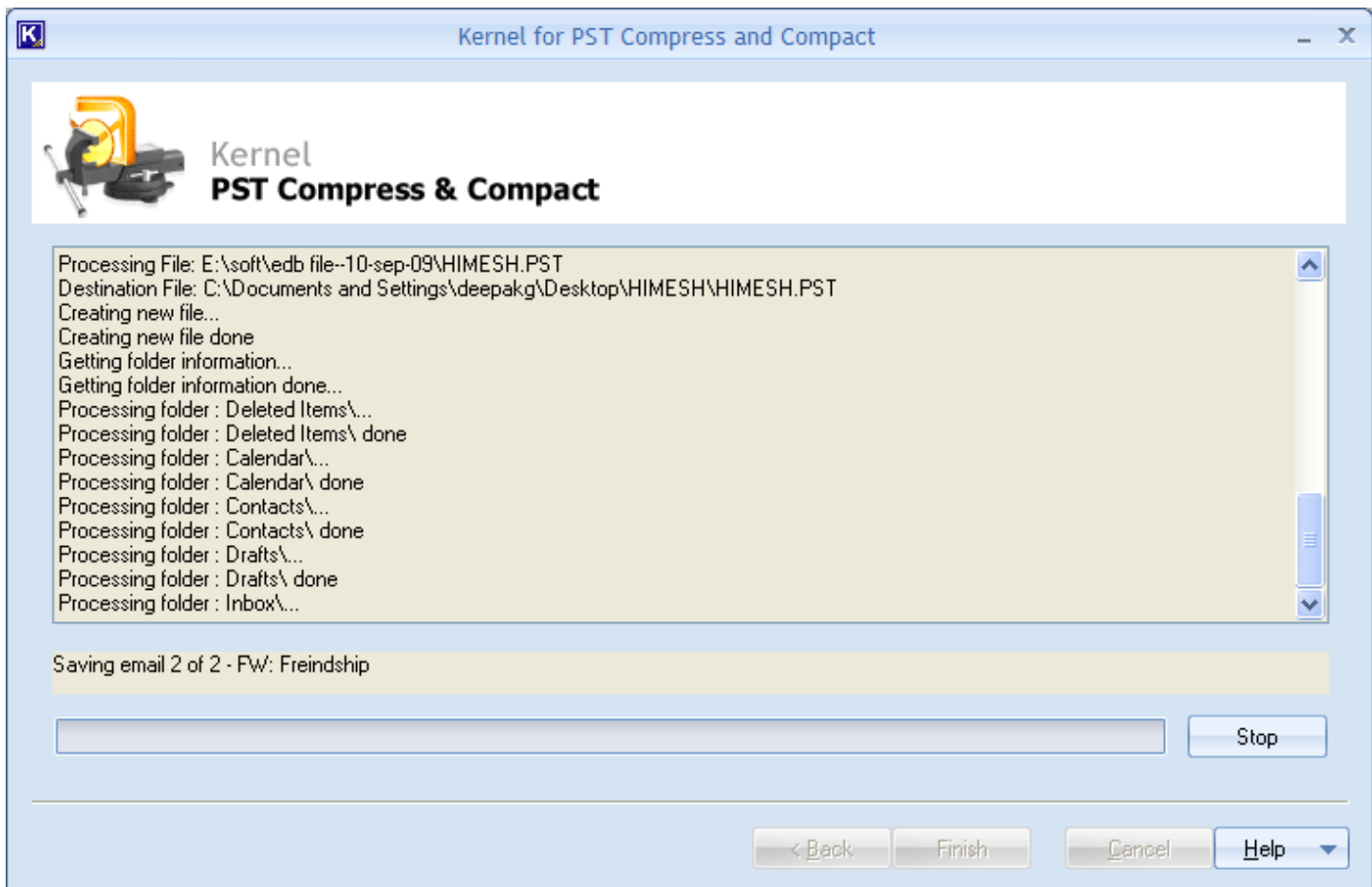


Figure 4.8: Compression and saving in progress

After the software completes the process of compressing selected PST file(s), the “Process is completed successfully” message appears along with the location where compressed PST file(s) is saved.”
